- **Puppies** under six months of age receive up to one-year registration at no charge.
- The **concession fee** applies to dog owners who are in receipt of a government pension (proof required).
- The **registered breeder fee** applies to owners of entire dogs who are members of Dogs NT and who have agreed to abide by the North Australian Canine Association Rules, Regulations and Code of Ethics (proof required).
- Owners of **working dogs** are required to provide evidence that they are carrying on a business of primary production and complete an **application for working dog registration concession form** which is available on the Council website.
