Please ensure that your dogs' details are kept up to date and that Council is notified in writing to council@litchfield.nt.gov.au of change of ownership of the dog, owner postal address or change of address where the dog is kept, contact details (mobile number), if the dog leaves the municipality and/or if the dog is deceased.

Failure to renew and maintain registration or update your or your dogs' details may result in an Unregistered Dog Infringement being issued under the Litchfield Council (Dog Management) By-Laws 2017
- Puppies under six months of age receive up to one year of registration at no charge (to 31 Aug current year).
- The concession fee applies to dog owners who are in receipt of a government pension (proof required).
- The registered breeder fee applies to owners of entire dogs who are members of Dogs NT and who have agreed to abide by the North Australian Canine Association Rules, Regulations and Code of Ethics.
- Owners of working dogs are required to provide evidence that they are carrying on a business of primary production and complete an application for working dog registration concession form which is available on the Council website.
